Sorting of construction/renovation waste

Practical details

1. Container parks of Bruxelles-Propreté

- •• Your operating site must be in the Brussels area.
- •• Submit a proof of address of the operating location and your identity card.
- •• Sort your waste by type in advance.
- Use a vehicle with a total weight of < 3.5t.
- •• The vehicle can only contain waste destined for the container park.
- •• Arrange the categories of waste so that they can be easily verified.
- •• Make personally sure that the waste is unloaded and deposited in the appropriate containers.
- •• You are charged for construction waste.

2. Removal of inert waste ("rubble") by Bruxelles-Propreté

In big-bag(s) (1m3) for a quantity of more than 15 sacs

- Delivery of the big-bag :
 - Arrange an appointment by calling the toll-free number 0800/981 81.
 - Your presence is mandatory the morning of the delivery of the big-bag with your identity card.

• Use

- Only unfold the big-bag only on the edge of the pavement, close to the gutter.
- Empty your wheelbarrows or bags of "rubble" into the big-bag.



Only put in "rubble"!

Collection

- Arrange an appointment by calling the toll-free number 0800/981 81. (if the appointment was not made during the first contact).
- Arrange for a parking place of 10m in front of the big-bag for his collection in the afternoon.
- You presence is mandatory the afternoon of the collection of the big-bag with your Identity card.
